Introduction

Project R.E.A.C.H.© (Resource Extraction for Amelioration of Cluster-wide Health) was created under the Syndicate Stability Initiative II© banner. Since its inception, I-RED has promoted the ideals of economic prosperity through cooperation, collaboration, and integration. This project exists as a manifestation of those ideals, and a dedication on behalf of I-RED to achieve them. By providing the infrastructure necessary to allow planetary extraction and production operations, two goals are accomplished; first, developers are able to produce goods which can contribute to both the planetary and interstellar economy; second, the Customs Offices in orbit act as a tool with which planet dwellers can integrate themselves with the interstellar economy, and truly become interstellar citizens. Thus, everyone benefits from this interaction.

Alongside the information outlined above, this project also funds a lobbyist movement in the Gallente Federation to lift the unspoken ban on the settlement of planets in Syndicate for colonial purposes. For too long the people of the Intaki Syndicate have been largely confined within the walls of space stations. They deserve better. They deserve the opportunity to walk on solid earth, and inhale breathable air the moment they step outside their home. The establishment of actual colonies on planets in Syndicate can also benefit the Federation as their neighbor will gain access to invaluable amounts of resources, manufacturing, and prosperity.

Project R.E.A.C.H.© serves as a model for positive change - for both capsuleer and non-capsuleer - so that everyone may reach for a brighter tomorrow.



Our Mission

Many non-capsuleers who work aboard customs offices or extraction sites sleep with ease knowing their hard work is paving the way to a brighter future for their community, and the cluster at large. By supplying markets across New Eden with planetary goods, I-RED is leading the way for a vibrant interstellar, and well-supplied, economy.



The Path So Far

Progress was in place well before the creation of the project; I-RED still owned and operated a number of customs offices in the 98Q superpocket. However, in recent weeks I-RED has aggressively been pushing for the reacquisition of old customs offices through trade deals and tactical asset redistribution methods. These techniques have proven largely successful, and now I-RED operates a total of twenty-nine customs offices in the 98Q superpocket. With the relocation of I-RED to Syndicate once more, the pre-existing customs offices which only operated on skeleton crews have now been upgraded to a full complement of crew, alongside any new customs office that is erected. Already, customs offices are proving their worth many times over by the income generated from low and fair tax rates. Customs office managers are also reporting a noticeable increase in planetary launches from capsuleer-owned facilities.

The Future

The future looks as promising as ever. Expansion plans are being formulated while others are being enacted. There is still a solid amount of progress left to be done, as a fair amount of customs offices in the pocket are under ownership of hostile entities or entities who violate the principles of open and free trade with exorbitant tax rates. Eventually, I-RED seeks to install customs offices in systems beyond the 98Q superpocket to see how they fair. Together alongside our allies, we look forward to securing a strong economic and prosperous future for the people - capsuleer and non-capsuleer - of Syndicate.
