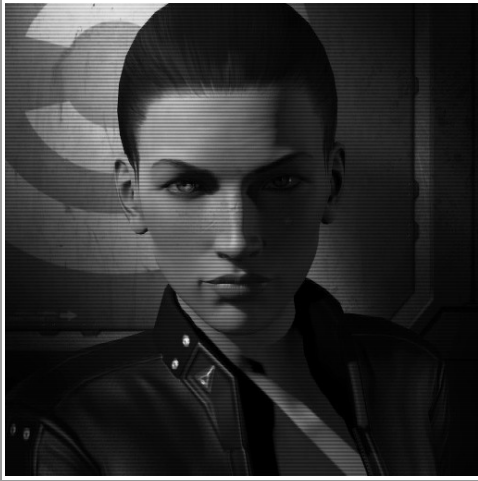

**Birth:** 10.07YC90; Wiyarkomi Colony K03 (since mothballed after purchase by Hyasyoda in YC102), Moon 1 (Hayato), Dantumi III, Okunda, Lonetrek  
**Death:** n/a; indefinite cloning contract initiated 25.05YC113 (SWA)  
**Status:** Wiyarkomi Citizen (status latent after receiving State-level capsuleer clearance, due for periodic review NLT 25.05YC118 [WC legal])  
**Contract:** Inactive; Wiyarkomi Peace Corps 11.07YC107 (officer; recoded, transferred); State War Academy 10.01YC111-25.05YC113 (closed [SWA])  
**Gene Sequence:** Current (high P1/P2 chromosomal vitality, natural life expectancy 140-160 years [WC medical]; wetlink defect trait apparent in Class 2 severity, strong MMI candidate [SWA screen]; 94% mitochondrial descent from Caldari Prime [CPD])

### Biographical Record Brief

- Parents are tier 3 managerial staff in Wiyarkomi-Okunda resourcing division
- Born at WC refinery colony on Hayato
- Entered creche at age 7 (YC97): Seituaoda's Promise Academy, Fort Diligence, Dantumi III
- Entered WPC reserves at age 16 (YC106); commissioned as a junior officer in Communications branch; discharged with rank of Lieutenant (YC110)
- Selected for capsuleer training by SWA at age 20 (YC110)

### Instructor Assessment Record Brief

- Unimpressive creche entrance aptitude screen, average first phase performance, not fast-tracked
- Placed on technical vocational training path after second phase aptitude testing in YC101
- Above average performance in mathematics, electronics, and signal technology in second phase
- Volunteered for Wiyarkomi Peace Corps reserve training at age 16 (YC106)

### Employer Assessment Record Brief

- Served as WPC reserve officer during advanced education
- Signed standard employment contract with Wiyarkomi in YC107
- SWA cadet YC111-113, enrolled in capsuleer candidacy program
- SWA graduate correspondence studies student and flight instruction assistant YC113-YC114
- Filled recurring security and logistical contracts with Wiyarkomi and Lai Dai Corporations as an independent capsuleer YC113-114; contracting agents noted exemplary performance

### Medical Record Brief

- Pre-natal and infant gene sequences showed strong natural health traits
- Broken hand and nose from a physical altercation at age 13
- Pod-compatible cerebral defect detected in routine 20-year gene sequence in YC110
- Ocular implants installed YC112, military-grade broad spectrum visual enhancement and data interface
- Hydrostatic capsule MMI implants installed YC113

### Counselor Assessment Record Brief

- Troublemaker as a pre-adolescent
- Poor cohesion with study unit, interpersonal problems
- Enrolled in social re-education program at ages 13-15
- Reformed as teenager, positively assessed for adult placement prospects
- Integrated well within WPC system

### Security Assessment Record Brief

- Subversive tendencies in adolescence, questionable galnet traffic
- Apparently loyal since signing life-contract
- Supported Provist movement during YC110
- Standard State security and surveillance package deployed during capsuleer candidacy; graduate assessed to be State-loyal (YC113)
- Appears in Federal Intelligence Office databases as high-threat capsuleer starting at the end of YC113
- Guristas issued internal bounty for live capture in early YC114
